Meeting Outcomes

The Independent Liquor & Gaming Authority (ILGA) held a board meeting on 21 August 2024 to consider, among other things, applications under the *Gaming and Liquor Administration Act 2007, Liquor Act 2007, Gaming Machines Act 2001, and the Registered Clubs Act 1976.* The next ILGA board meeting is scheduled for 18 September 2024.

An application under the *Gaming and Liquor Administration Act 2007* and *Liquor Act 2007* was also considered out of session.
