

NSW Independent Liquor & Gaming Authority

Meeting Outcomes

The Independent Liquor & Gaming Authority (ILGA) held a board meeting on 18 September 2024 to consider, among other things, applications under the *Gaming and Liquor Administration Act 2007*, *Liquor Act 2007*, *Gaming Machines Act 2001*, and the *Registered Clubs Act 1976*. The next ILGA board meeting is scheduled for 16 October 2024.

ILGA considered the following matters, and the status of each matter is listed below.

Definitions:

Approved – The application has been approved. The approval may be subject to conditions or provision of certain information.

Partially approved – The application has been partially approved, for example authorising less extensive trading hours or licensed area than what the applicant sought.

Refused – The application has been rejected.

Under consideration – The matter is yet to be determined. A decision will be published once finalised.

Determined – This disciplinary matter or review application has been considered and determined by the ILGA board, with decisions to be published where applicable.

Not considered – The matter was not considered by ILGA at this meeting.

Withdrawn – The application has been withdrawn.
