Decision of the Independent Liquor & Gaming Authority

Application for a new (full) hotel licence with extended trading authorisation & minors' area authorisation - Empire Hotel

We **approve** the application above under section 45 of the *Liquor Act 2007* — with the conditions set out in Schedule 1. The 6-hour closure period overrides any condition of the licence.

Approved manager or individual licensee

The licence cannot be exercised until the Authority or Liquor & Gaming NSW is notified that:

- the licence is transferred to an individual licensee, or an approved manager is appointed; and
- the licensee or approved manager is a suitable and qualified person.

Statement of reasons

We are satisfied that the overall impact of approving the application will not be detrimental to the well-being of the local or broader community, while also promoting a balanced and responsible development of the industry.

Our main findings

The local community for the purposes of this decision is Young. The broader community is the Local Government Area (LGA) of Hilltops.

Positive social impacts

The application is for a new hotel licence with extended trading authorisation and minors' area authorisation at the proposed premises where the previous Empire Hotel traded since the 1880's until the licence was cancelled in 2022 during the Covid-19 pandemic. The proposed premises will not operate gaming machines and reduced the proposed trading hours following concerns raised by the Police.

We are satisfied that the proposal would benefit the local and broader communities by providing increased convenience and choice.

Negative social impacts

We noted objections from the public (including two hotel competitors) and NSW Police and accept that the proposal could contribute to an increase in alcohol-related harm in the local and broader communities due to the:

- location of the proposed premises being in high-density crime hotspots for all categories we considered
- crime rates for all categories we considered being higher in the suburb and LGA than in NSW
- saturation rate of licensed premises in both the suburb and LGA being higher than the NSW rate
- rate of alcohol-attributed deaths in the LGA being higher than in NSW generally
- indication of relative socio-economic disadvantage in the suburb and LGA
- indigenous population in the suburb and the LGA being higher compared to the NSW average.

However, we are satisfied that these risks are reduced due to the:

applicant reducing the trading hours

- security presence on Thursday to Saturday evenings as described within the plan of management (including an additional guard when a function is held with 50 or more patrons)
- lower rate of alcohol-attributed hospitalisations in the LGA than NSW generally
- harm-minimisation measures outlined in the plan of management and licence conditions, as set out in Schedule 1. This includes additional conditions that were not imposed on the previous licence at the same location.

The material we considered

We considered the following material when making our decision:

- the application material including evidence that stakeholders and the community were notified about the application
- a Statement of Risks and Potential Effects (SoRPE)
- the plan of the licensed premises and any authorisations
- a plan of management for the licensed business
- previous Empire Hotel licence
- statistics from Liquor & Gaming NSW, Bureau of Crime Statistics and Research, NSW Health and Australian Bureau of Statistics on the socio-economic status, liquor licence density, alcohol-related crimes rates and health issues in the local and broader communities
- stakeholder submissions and the applicant's response to them.

We also considered <u>Guideline 6</u> to assess the likely social impact to the local and broader community.

This decision will be published on the Liquor & Gaming NSW website in accordance with section 36C of the *Gaming and Liquor Administration Act* 2007.

Opportunity for review

The applicant and anyone who was notified of the application and made a submission, may apply to NCAT for a review of the decision.

An application for review must be made no later 28 days after the decision is published on the website. There is a fee to lodge the application.
