

MEETING OUTCOMES

A statutory board established under the Gaming and Liquor Administration Act 2007

The Independent Liquor & Gaming Authority (ILGA) held a board meeting on **17 May 2023** to consider, among other things, applications under the *Gaming and Liquor Administration Act 2007, Liquor Act 2007, Gaming Machines Act 2001,* and the *Registered Clubs Act 1976*. The next ILGA board meeting is scheduled for **21 June 2023**.

Definitions:
