

MEETING OUTCOMES

The Independent Liquor & Gaming Authority (ILGA) held a board meeting on **21 June 2023** to consider, among other things, applications under the *Gaming and Liquor Administration Act 2007*, *Liquor Act 2007*, *Gaming Machines Act 2001*, and the *Registered Clubs Act 1976*. The next ILGA board meeting is scheduled for **19 July 2023**.

Out of session meetings of the ILGA Newcastle Committee were held on **13 June 2023** and **28 June 2023** to consider applications under the *Liquor Act 2007*.

ILGA considered the following matters, and the status of each matter is listed below.
