

MEETING OUTCOMES

The Independent Liquor & Gaming Authority (ILGA) held a board meeting on **24 January 2024** to consider, among other things, applications under the *Gaming and Liquor Administration Act 2007*, *Liquor Act 2007*, *Gaming Machines Act 2001*, and the *Registered Clubs Act 1976*. The next ILGA board meeting is scheduled for **21 February 2024**.

Certain applications under the *Gaming and Liquor Administration Act 2007*, and *Gaming Machines Act 2001* were also considered out of session.

ILGA considered the following matters, and the status of each matter is listed below.
